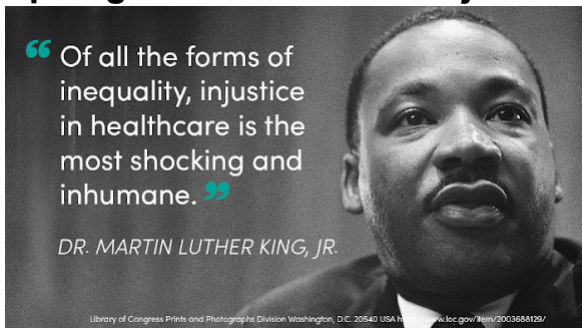

Spotlight on: Healthcare Injustice

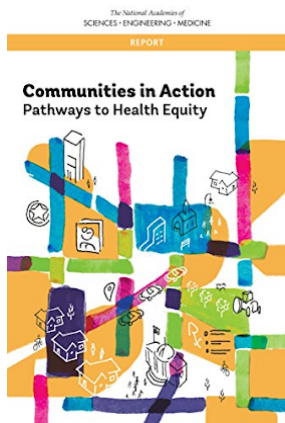

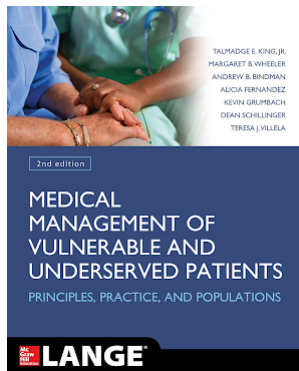
